### Notification

No. LA/CB/S/ML- Lime Stone/69(05)/18/329: Being the competent authority in his capacity as the Licencing Authority—made by the Government of Sindh through an amendment to Rule 21(1) of the Sindh Mining Concession Rules, 2002 ("the Rules") at the Cabinet meeting held on 19<sup>th</sup> February 2018, notified in the Sindh Government Gazette Number M-324, published on 22<sup>nd</sup> March 2018—and pursuant to para 22 of the order dated 12<sup>th</sup> December 2018, passed by the High Court of Sindh, Bench at Sukkur, in CP No. 3602 of 2016, filed by M/s Rohri Cement Factory Limited, the undersigned is pleased to suspend the restoration made up to 31<sup>st</sup> December 2027 of the mining lease for lime stone over an area of 659.0 acres at / near Rohri, District Sukkur (without the ownership of land) to M/s. Associated Cement Rohri Limited, Rohri, as per the annexed map/drawing, under the Notification No. DMD/S/ML- Lime Stone/69(05) 17/180 dated 27.2.2017.



A copy is forwarded, for information and further necessary action, to:

1. **M/s. Associated Cement Rohri Limited, Rohri.** They are informed that the competent authority, stated as above, has suspended the mining lease as mentioned in the notification above. So, they are required to stop the mining operations in the area, remove all **their** machinery, *etc.*, if any, from the site, and hand the area over to the concerned officer of this Department within one month to be spared from the departmental action under the Rules.
2. ✓ The Deputy Commissioner, District Sukkur.
3. The Deputy Director, Mineral Development, Sukkur. He is directed to take all appropriate measures to stop the mining operations on site of the **suspended** concession, remove the machinery, *etc.*, if any, from the site, and take over the possession of the area from the holder of the **suspended** mining concession, along with other necessary actions under the Rules (such as Rule 106) and other laws of the land and the government policies, relevant to the case, in due course of time.

4. The Chief Inspector of Mines, Government of Sindh, Karachi.
5. The Commissioner, Mines Labour Welfare, Government of Sindh, Karachi.
6. The Joint Secretary, Central Statistical Division, Government of Pakistan, Karachi.
7. The Senior Superintendent of Police, District **Sukkur**. He is requested to issue the necessary directives to the concerned police officers/officials for taking further necessary action to get the mining operations in the **suspended** mining concession area immediately stopped and reported to this Department.
8. The Station House Officer (concerned). He is required to take immediately the further necessary action to stop the mining operations by the party in the area under reference, as the mining permit in question has been **suspended** by the competent authority (i.e., the Licencing Authority, referred to above).
